ORDER (ORAL)

Hon'ble Mr. P.K. Basu, Member (A)

The prayer in this OA is for grant of regularization of services of the applicants w.e.f. the date of their initial engagement as Lighting Assistants with all consequential benefits, including re-fixation their seniority in the said grade and

consequential promotions accordingly, at par with their counter parts in Ranchi Doordarshan, where the similarly placed Lighting Assistants have been granted regularization from the date of their initial engagement whereas applicants have been regularised from the date of their regularization.

2. At the outset it is stated by the learned counsel for the respondents that department has already reviewed the order of Ranchi Doordarshan by which the similarly placed Lighting Assistants had been regularised from the date of initial engagement as Lighting Assistants by withdrawing the order and now regularised the services of aforesaid Lighting Assistants from the date of their regularisation. Therefore, the ground of parity no longer exists and the OA has become infructuous.

3. Learned counsel for the applicants states that the aforesaid withdrawal order in case of Ranchi Doordarshan has been challenged by some aggrieved Lighting Assistants, namely, P.K. Jha, A.Satish Kumar, Nand Kumar and Saruj Das before the Ranchi Bench of this Tribunal through OA NO. 051/00442 of 2016 and the Ranchi Bench of this Tribunal vide order dated 28.06.2016 has been pleased to stay the recovery of amount from the applicants therein.

4. As of today, therefore, the main cause of action of the applicants in this OA no longer survives as the respondents have now also regularised the services of the Lighting Assistant of Ranchi Doordarshan from the date of their regularisation itself and not from the date of their initial appointment. The OA has become infructuous and is, therefore, dismissed as such. However, the applicants are at liberty to revive this OA, if so advised under the provisions of law appropriately after the final order is passed in OA No. 051/00442/2016. No costs.
