ORDER (ORAL)

Heard the learned counsel for the applicants and Shri Yogesh Mahur representing Shri Gyanendra Singh, who accepts notice on behalf of the respondents.

2. MA 3467/2015, filed under Rule 4(5)(a) of C.A.T. (Procedure) Rules, 1987 for joining together, is allowed.

3. The applicants, who are retired from various Group 'D' posts under the respondents, filed the present O.A. seeking the following relief(s):

- (i) Direct the respondents to grant selection grade after 8 years service as per the CPWD OM dated 09/06/11 to the applicants as per their entitlement from the due date.
- (ii) Direct the respondents to accordingly grant corresponding revised pay scale as applicable to the applicants.
- (iii) As a consequence of relief (i) & (ii) being granted, the respondents be directed to arrears as per their entitlement and as per terms given in the OM dated 09/06/11 as well as revise their pension & pensionary benefits within a specified time frame.
- (iv) Award costs and

- (v) Pass any other order/direction as may be deemed just & proper in the facts and circumstances of the case.”

4. It is submitted that the applicants made number of representations ventilating their grievances vide Annexure A (Colly.), However, the respondents have not passed any orders thereon till date.

5. In the circumstances, the O.A. is disposed of at the admission stage, without going into the merits of the case, by directing the respondents to consider the Annexure A (colly.) representation of the applicants and to pass appropriate speaking and reasoned orders thereon, in accordance with law, within 90 days from the date of receipt of a copy of this order. No order as to costs.
