**: O R D E R (ORAL) :**

**Justice Permod Kohli, Chairman:**

This Application has been filed under Section 19 of the Administrative Tribunals Act, 1985. In para 2 at page 33 of the OA, the applicant has mentioned that “petitioner is employee of Sikkim Govt. and NEEPCO”. The dispute of the applicant is with the North East Electrical

Power Corporation Limited which is a Government of India undertaking and is arrayed as respondent No.4 through Chairman and Managing Director.

2. The applicant had earlier sought time to place on record copy of the articles and memorandum of association of respondent No.4 Corporation. He has not placed on record any such document. Apart from that, admittedly, North East Electrical Power Corporation Limited is not a notified organisation under Section 14 (2) of Administrative Tribunals Act, 1985, and thus this Tribunal cannot exercise jurisdiction over the said Corporation or any service dispute relating to an employee of the said Corporation. The applicant claims to be an employee of Sikkim Government and North East Electrical Power Corporation Limited. This Tribunal cannot exercise jurisdiction in respect to an employee of the Sikkim Government.

3. For both the above reasons, this Application is dismissed for want of jurisdiction with liberty to the applicant to approach the appropriate jurisdictional forum.
