O R D E R (O R A L)

Heard both sides.

2. The applicants, all retired from service prior to 01.01.2006 in S-24 scale of pay filed the O.A seeking the following reliefs :-

- “(i) Call for the records of the case
- (ii) Direct the Respondent to apply the ratio of All India S-30 Pensioners Association Vs. UOI in OA No. 937 of 2010 with OA No. 2101 if 2010 delivered on 20.11.2014 and in the RA/10/2015 in OA No. 937 of 2010 dated 24.09.2015.
- (iii) Direct the Respondents to fix the pension of each of the Applicants at Rs. 37850/- thus extending the benefits of Full parity as has been granted in the case of S-30 Association by CAT (PB), New Delhi; and / or
- (iv) Direct the Respondents to grant higher NFU in SAG to the Applicants as permissible and revise their pension accordingly.
- (v) Direct the Respondents to grant Notional Promotion to the post of DDG in the Grade Pay of Rs.10000/- with retrospective effect and fix their pension accordingly.
- (vi) Grant Notional promotion after 13 years of Group “A” service and notional increments thereafter till retirement and to arrive at the notional pay with those increments w.e.f. 01.01.2006, and to fix consequent pension and pensionary benefits accordingly.

Grant any other relief which the Hon’ble Tribunal may deem appropriate for the benefit of the Applicants.”

3. When this matter is taken up for hearing today, it is noticed that the applicants have not made any specific representation either individually or through any Association ventilating their exact grievances to the respondents before filing the O.A.

4. In the circumstances, the O.A is disposed of without going into the merits of the case by permitting the applicants to make a proper and specific representation ventilating their grievances, by enclosing the copy of the judgment in All India S-30 Pensioners Association Vs. Union of India in O.A No. 937 of 2010 with O.A. No. 2101 of 2010 dated 20.11.2014, on which they are placing reliance for claiming parity, to the respondents, within a period of six weeks from the date of receipt of a copy of this order and on receipt of such

representations from the applicants, the respondents shall consider the same and pass an appropriate speaking and reasoned order thereon, in accordance with law within a period of 90 days therefrom.
