M.A. No. 3475/2018 & M.A. No. 3474/2018 which have been filed for joining and condonation of delay are devoid of merit and are dismissed.

O.A. No. 3108/2018

Learned counsel for the applicants mentioned that certain recoveries have been ordered for certain excess payments made against some persons. These persons are not included in the present petition. The petitioners in the instant case are, however, apprehensive that similar recoveries may be ordered against them also in future and this apprehension is the grievance in the present O.A.

2. Learned counsel for the respondents mentioned that no such recovery order has been issued by the department against any of the applicants in the present petition. Hence, there is no cause of action.
