### **ORDER (ORAL)**

#### **By Mr. V. Ajay Kumar, Member (J)**

Heard Shri G.S. Charya, learned counsel for the applicants and Shri Aman Kumar proxy for Shri Kumar Omkareshwar, learned counsel appeared on behalf of the respondents on receipt of advance notice.

2. MA 4098/2018 filed for joining together is allowed.
3. The applicants filed the O.A. seeking the following relief(s):
  - (a) Pass an order directing the respondents to grant the Minimum Entry Pay of Rs.12540/- + 4600 (Grade Pay) = Rs.17140/- to applicants w.e.f. 01.01.2006 in light of Hon'ble Tribunal judgment in the case of Somveer Rana & Ors. vs. Govt. of NCT of Delhi & Ors. (O.A. No.3217/2014) dated 04.04.2016 which has been upheld by the Hon'ble Delhi High Court and Hon'ble Supreme Court of India with all the consequential benefits including the arrears of difference of Pay and Allowances;

- (b) direct the respondents to grant Entry Scale for TGT irrespective of subject from 01.01.2006 to the applicants with all consequential benefits as per the various judgments mentioned above;
- (c) direct the respondents to grant same relief to applicants who joined as PGT teachers prior to 01.01.2006;
- (d) further direct the respondents to not to recover any excess amount from the applicants, if already paid, as all these applicants were employed prior to 01.01.2006 and/or not to initiate any recovery of excess amount from the applicants in cases where the process of recovery has not been initiated.”

4. It is submitted that the applicants made number of representations vide Annexure A-1 (Colly.) ventilating their grievances to the respondents. However, no orders have been passed thereon till date.

5. In the circumstances, the O.A. is disposed of at the admission stage itself, without going into the merits of the case, by directing the respondents to consider Annexure A-1 (Colly.) representations of the applicants and to pass appropriate reasoned and speaking orders thereon, in accordance with law, within 90 days from the date of receipt of a certified copy of this order. No order as to costs.
