**ORDER (ORAL)**

Heard the learned counsel for the applicants.

2. MA 3946/2018 filed for joining together is allowed.

3. The applicants filed the O.A. seeking the following relief(s):

- “(a) To issue appropriate directions to the respondents to regularize them to Grade-IV LDC (Group C) post retrospectively w.e.f. 03.07.2008 when they were appointed to the said post or in alternative w.e.f. 03.07.2011 when the maximum time of 3 years permissible for adhoc appointment was over.
- “(b) Any other or further relief which this Hon’ble Court deems fit, just and proper in the peculiar circumstances of the case in the interest of justice may also please be awarded.”

4. It is submitted that the applicants made number of representations including Annexure A-11 (colly.) ventilating their grievances to the respondents. However, no orders have been passed thereon till date.

5. In the circumstances, the O.A. is disposed of at the admission stage itself, without going into the merits of the case, by directing the respondents to consider Annexure A-11 (colly.) representations of the applicants and to pass appropriate reasoned and speaking orders thereon, in accordance with law, within 90 days from the date of receipt of a certified copy of this order. No order as to costs.
