ORDER (ORAL)

Heard the learned counsel for the petitioners.

2. The instant CP is filed alleging violation of the order of this Tribunal dated 10.04.2018 in O.A. No.1157/2018, which reads as under:

“Heard the learned counsel for applicant.

MA No.1295/2018

2. For the reasons stated therein, the MA filed for joining together in a single Application is allowed.

MA No.1296/2018

3. For the reasons stated therein, the MA filed for exemption is allowed.

OA No.1157/2018

4. Issue notice to the respondents.
 5. Shri Rishabh Sahu, learned counsel, appears and accepts notice on behalf of respondents. He seeks and is allowed four weeks time to file reply.
 6. List the matter before the Principal Registrar's Court for completion of pleadings on 04.07.2018. In the meanwhile, respondents shall engage the applicant, if there is work, and in preference of his juniors and freshers.”
3. The applicants filed the C.P. along with Annexure CP/2 and submit that the names shown in Annexure CP/2 are the names of the persons who are freshers and juniors to them and engaged ignoring the claims of the applicants, in violation of the orders of this Tribunal.
4. The Annexure CP/2 nowhere indicates that the persons, whose names were shown therein, are engaged under the respondents. It is also not the case of the applicants that they have issued any representation or legal notice to the respondents with regard to their claim.
5. In the circumstances, we do not find any merit in the C.P. and, accordingly, the same is dismissed. No costs.
