ORDER (ORAL)

Mr. V. Ajay Kumar, Member (J) :-

Heard the learned counsel for applicant.

MA No.4293/2018

For the reasons stated therein, the MA filed for joining together in a single Application is allowed.

OA No.3834/2018

The applicants are working as Home Guards under the respondent, Govt. of NCT of Delhi. However, admittedly, their service is voluntary and they are not the employees of any of the respondents. The Hon'ble High Court of Delhi in WP(C) No.375/2001 and No.4388/2001 decided on 29.04.2002 in **Rajesh Mishra & Ors. Vs. Govt of NCT of Delhi and Ors.**, held that Home Guards cannot be said to be the civil servants and as such the Tribunal has no jurisdiction to entertain the applications under Section 19 of the Administrative Tribunals Act, 1985.

2. In the circumstances and in view of the decision of the Hon'ble High Court of Delhi in **Rajesh Mishra & Ors.**, the instant OA is liable to be dismissed. At this stage, learned counsel for applicants

seeks leave of this Tribunal to withdraw the OA with liberty to approach competent Court, in accordance with law.

3. Though the applicants initially approached the Hon'ble High Court of Delhi in WP(C) No.9483/2018 and the same was permitted to be withdrawn with liberty to move this Tribunal, but the issue of jurisdiction of this Tribunal to entertain the claims of the applicants was not agitated before the Hon'ble High Court and the said order was passed only basing on the prayer of the applicants.

4. In the circumstances, the OA is dismissed as withdrawn, with liberty to the applicants to approach a competent Court, in accordance with law. No costs.
