When this Contempt Petition was taken up for hearing, learned counsel for the respondents while producing the office order dated 08.11.2018 whereunder the applicants were promoted on regular basis to the post of Assistant Director submits that by promoting the applicants under the said order, they have fully complied with the orders of this Tribunal and accordingly prays for dismissal of the CP.

2. Sh. M.K. Bharadwaj learned counsel for the petitioners while not disputing the fact of promotion of the applicants by the respondents, however, submits that the applicants are entitled for retrospective promotion and other reliefs.
3. In the circumstances and in view of the substantial compliance of the order of this Tribunal, this CP is closed. Notices issued to the alleged contemnors are discharged. The petitioners are however at liberty to avail their remedies in accordance with law, if they still have any other grievances. No costs.
