### **ORDER (ORAL)**

This OA is filed challenging office order dated 04.03.2018 passed by the respondents. Through the said order, the benefit extended to 158 Senior Translators of Central Secretariat Official

Language Services (CSOLS) has been withdrawn and ad hoc arrangements in which they are continued were stopped.

2. Today, learned counsel for respondents placed before us, copy of an office order dated 18.01.2018, through which, the office order dated 14.03.2018 has been superseded. The applicants were extended the benefit, which they were enjoying before the impugned order came to be issued. In view of this development, the OA has become infructuous and the same is dismissed.

3. In view of the above, all ancillary applications stands disposed of.

There shall be no order as to costs.
