### **ORDER (ORAL)**

**Mr. K.N. Shrivastava :**

Mr. J.S. Mann, learned counsel for applicants submits that identical controversy involved in this OA has already been adjudicated by the Tribunal vide order dated 30.10.2018 in OA No. 463/2018 (**Soma & Others. vs. Govt. of NCTD & Others** and some other OAs), and as such, this OA, can also be disposed of in terms of the said order.

2. Mr. Amit Yadav, learned counsel for respondent No. 1 & 2 submits that the order of the Tribunal in Soma & Others (supra) relates to the post of Assistant Teacher (Primary) - Post Code 16/17 in the Directorate of Education, Govt. of NCTD, whereas, in the instant case, it is relating to Teacher (Primary) in South DMC, and, hence, the age relaxation is to be granted by South DMC which has not been done.

3. We have perused the records. The controversy relates to the age relaxation for female candidates. All these applicants are female candidates and had participated in the selection for the post of Teacher (Primary) in South DMC and have sought benefits of the age relaxation, as available to the female candidates. We notice that the Tribunal, while adjudicating the controversy in **Soma** (supra), had

taken cognizance of the circular dated 01.11.1980 issued by Directorate of Education, Delhi Administration, whereby age relaxation of 10 years has been granted to the female candidates.

4. Pertinent to note that Lt. Governor of Delhi is Administrator of all three Municipal Corporations of Delhi and the circular dated 01.11.1980 has been issued by his approval. Hence, we are of the view that these applicants are also entitled to the age relaxation benefits in terms of the *ibid* circular and no separate age relaxation order is required to be issued by South DMC.

5. In view of the above, this OA is allowed. DSSSB (respondent No. 2) is directed to consider the applications of the applicants in terms of Delhi Government circular dated 01.11.1980 granting them the necessary age relaxation.

6. In view of the disposal of the OA, no separate order is required to be passed in MA No. 3091/2018, which has been filed seeking exemption from filing the handwritten documents. The MA accordingly stands disposed of.

There shall be no order as to costs.
