### **ORDER (Oral)**

**By Shri K.N. Shrivastava, Member (A):**

#### **MA No.4087/2018**

This MA filed for joining together is allowed.

#### **OA No.3675/2018**

Issue notice to the respondents. Shri S.N. Verma, learned counsel appears and accepts notice on behalf of the respondents.

Pursuant to Annexure A-2 Advertisement of Chief Post Master General, Delhi, inviting applications for the posts of Postman/Mail Guard in November, 2014, the applicants applied for the said posts. The written examination was conducted between 17th to 21st May, 2017. The applicants appeared in the written examination. Their names do not figure in the select list. The applicants are not informed as to whether their names figure in the waiting list published by the respondents.

2. The applicants approached this Tribunal in OA No.2144/2018, which was disposed of vide order dated 28.05.2018 with a direction to the respondents to decide the pending representation of the applicants dated 23.04.2018. In compliance of the Tribunal's

direction, the respondents have decided the representation of the applicants vide Annexure-A-1 order dated 26.07.2018, in which, *inter alia* they have stated as under:

"3. It is further intimated that the candidates in the waiting list may be considered as per provisions only after conclusion of appointment process of selected candidates. As the appointment process of the selected candidates has not been completed so far, hence, the number of candidates to be considered from waiting list in the respective category, cannot be ascertained at this stage."

3. Shri Amit Chawla, learned counsel for the applicants submits that the applicants have not informed as to whether their names figure in the waiting list. He placed on record a letter dated 06.08.2018 issued by the respondents to another candidate, namely, Shri Jitender S/o Shri Jagdish, who too had appeared in the written examination. Through this letter, the respondents have informed that Shri Jitender has secured 79 marks and his name figures in the waiting list. Learned counsel for the applicants submits that the applicants would be satisfied, at this stage, if similar intimation is sent by the respondents to these applicants as well indicating therein the marks secured by them and whether their names are in the waiting list or not.

4. Having regards to submissions made, we dispose of this OA, at the admission stage, in the following terms:-

***i) The applicants shall submit a representation to respondent No.2, inter alia, seeking information as to the marks secured by them in the written examination and***

***existence of their names in the waiting list. This shall be done within 15 days from today.***

***ii) The respondent No.2 is directed to dispose of such representation within four weeks from the date of its receipt by way of a reasoned reply/order.***
