The learned counsel for the applicants submits that the subject matter of this OA is covered by the order passed by this Tribunal in OA 1622/2014 and the same has been upheld by the Hon'ble Delhi High Court through judgment dated 25.04.2017 in W.P. (C) 109/2016. Learned counsel for the respondents does not dispute this.

2. In view of the same, we allow this OA holding that the applicants herein are entitled to Grade Pay of Rs.7600/- in the

third MACP with effect from the date on which they completed the required length of service. M.A. pending, if any, shall also stand disposed of.
