applicants, Shri. Sunil Jacob Jose, Standing Counsel for the Railways and
Smt. Shameena Salahudheen on behalf of respondent Nos. 7 to 20.

2. Shri. Sunil Jacob Jose, Standing Counsel for the Railways submitted that in compliance with the directions of this Tribunal, all applicants who had sought inter-divisional transfer from Palakkad Division to Trivandrum Division have since been permitted to join in Trivandrum Division and all RRB fresh recruits, who are arrayed as respondent Nos. 7 to 20 have also joined in Trivandrum Division.

3. It is seen nothing remains further to be adjudicated in this OA. Hence, the OA is disposed of with a further direction that the applicants, who have come on inter divisional transfer from Palakkad Division, will be ranked above the fresh recruits, who had come through the RRB. MA Nos. 626/2018, 497/2018, 350/2018 and 511/2018 are disposed of. No costs.
