The application having been heard on 04.07.2018, the
Tribunal on the same day delivered the following:

O R D E R (Oral):-**Per: Bharat Bhushan, Administrative Member**

Applicant is a Primary Teacher (PRT) in Kendriya Vidyalaya, Ramavarmapuram and is aggrieved by the non-consideration of her request for transfer to Kendriya Vidyalaya, Puranattukara, Thrissur on spouse ground. By orders at Annexure A-3, it is submitted that a direct recruitee from North India is being posted to the Station for which the applicant has raised a claim on spouse ground.

2. As agreed to by both sides, this Tribunal is of the view that the O.A can be disposed of at the admission stage itself by directing the Respondent No. 1 / 2 to consider and take a decision on Annexure A-4 representation within a month from the date of receipt of a copy of this order. In view of the fact that the date of joining for the transferees is 22.07.2018, this Tribunal directs that the representation of the applicant should be disposed of before that date. Ordered accordingly.

3. The O.A is disposed of as above. No order as to costs.
