Applicant is a Superintendent of Police (non-IPS) who has retired from service on 31.7.2017. Sri Saju Wahab learned counsel for the applicant submitted that as far as his knowledge goes the applicant is in the zone of consideration for 2016 vacancies as well as for 2017 vacancies. He apprehends that the fact of his retirement would stand in the way of his consideration for selection to IPS.

2. At this point the OA can be disposed of with a direction that the retirement of the applicant would not bar his being considered for selection to the IPS. Ordered accordingly.

3. The Original Application is disposed of. No order as to costs.
