ORDER(ORAL)**By Hon'ble Mrs.P.Gopinath, Administrative Member**

Applicant is working as an Assistant Cook with respondent organisation at Trivandrum. He prays for a direction to the respondents to complete the process as per Annexure A-1 selection to the post of Catering Supervisor Grade III.

2. The respondents by communication dated 17.10.2018 placed before us submit that the written examination for the said selection is fixed to be held on 27.10.2018 and all those who have volunteered for the selection process are required to appear for the written examination on the said date. Counsel for the applicant points out that Annexure A-1 is a tentative time schedule for the selection process which details a time span of 2 1/2 months from the date of written examination to declaration of results. Whereas the dates in this schedule are not material, the time schedule drawn up by respondent for the examination is an important time schedule for completion of the process of selection.

3. We direct the respondents to follow the tentative examination time schedule and conduct the examination and declare the results as per 2 1/2 months timeline laid down, from the date of written examination to the date of publishing the select list. Ordered accordingly.

4. The Original Application is disposed of as above. No costs.
