The grievance of the applicant is that during the selection for the post of Nursing Officer/Staff Nurse Grade II, after having passed the Computer Based Test and while appearing for the document verification, and for reasons unconnected with her eligibility, there was a mismatch between the finger prints taken during Computer Based Test and at the time of document verification. As

per Annexure A-6, respondents have submitted that this issue is being examined in detail and her candidature has been kept in abeyance.

2. We feel that at this point, the Original Application can be disposed of by directing respondent no.1 to take an expeditious decision in the matter taking into account also the facts detailed in Annexure A-7 representation filed by the applicant. This shall be done within 15 days of receipt of a copy of this order.

3. The Original Application is disposed of as above. No order as to costs.
