3. The applicant is aggrieved that she is being paid less pay than a junior of hers by name Smt. Sathyabhama. It is alleged that the said junior has five years less service than the applicant. A representation which she has filed before 4th respondent dated 24.11.2017 (copy is at Annexure A.3) is still pending.

4. Having heard both sides, we feel at this stage that ends of justice would be met if a direction is given to Respondent No.4 to dispose of the pending representation. Accordingly, Respondent No.4 is directed to consider and dispose of Annexure A.3 representation within a period of three months from the date of receipt of a copy of this order by a speaking order and communicate the same to the applicant.
