ORDER (ORAL)

Heard the learned counsel for the applicants.

2. MA 2046/2018 filed for joining together is allowed.
3. The applicants, who retired in the STS Grade, filed the O.A. seeking the following relief(s):

- “(a) To direct the Secretary Dept. Of Telecom to dispose of the representations of applicants with reasoned and speaking order within a period of Six weeks to extend the benefits at par with his juniors in view of the Hon’ble Supreme Court Judgements dated 21.1.2015 & 14.12.2017 in CA No.(s)4389 of 2010 and other judgments available on the same issue.
- (b) The applicants shall be at liberty to take appropriate remedial measures as available to them under law, in case remain dissatisfied with the order passed by Respondent no.1.”

4. It is submitted that the applicants made number of representations vide Annexure A-1 to Annexure A-8 ventilating their grievances to the respondents. However, no orders have been passed thereon till date.

5. In the circumstances, the O.A. is disposed of at the admission stage itself, without going into the other merits of the case, by directing the respondents to consider Annexure A-1 to Annexure A-8 representations of the applicants and to pass appropriate speaking and reasoned orders thereon, in accordance with law, within 90 days from the date of receipt of a certified copy of this order. No order as to costs.
