### **ORDER (ORAL)**

#### **Justice L. Narasimha Reddy:-**

This contempt case is filed alleging that the respondents did not implement the Order dated 29.05.2015 in OA No.1994/2015. The case has undergone several adjournments. The respondents filed a counter affidavit stating that the Order has since been implemented in the form of passing of order dated 12.04.2016. It is further stated that the actual adjudication has taken place in OA Nos.966 and

967/2009 before the Madras Bench of the Tribunal, which, in turn, led to filing of SLP and as of now the Review Petition is pending before the Hon'ble Supreme in respect of that case.

2. We have heard Shri Ajesh Luthra, learned counsel for the applicants and Shri Hanu Bhaskar, learned counsel for the respondents.

3. Two developments have taken place in this case. First is that in compliance of the Order in the OA, the respondents passed an order dated 12.04.2016. Secondly, the very foundation for the relief granted in the OA, being the order passed by the Hon'ble Supreme Court in SLP, is said to be under Review.

4. In this view of the matter, we close the contempt case leaving it open to the applicants to pursue their remedies depending upon the outcome of the Review Petition, pending before the Hon'ble Supreme Court. MA No.3484/2016 also stands disposed of.
