### **ORDER(ORAL)**

**Hon'ble Mrs. Jasmine Ahmed, Member (J)**

This OA has been filed by the applicants seeking the following reliefs:-

- “(a) Quash/Set aside the impugned Notice/order bearing No.AO(H)/CB/SDMC/2018/473 dated 07.05.2018 vide which applicants services will be terminated from the post of Auxiliary Nurse Midwife (ANM) w.e.f. 06.06.2018, in the interest of justice;
- (b) Direct the respondents, particularly respondent No.2 not to terminate the services of the applicants from the posts on

which they are working and further allow to continue as such on their respective posts, in the interest of justice.

- (c) Pass such other and further order as this Hon'ble Tribunal may deem fit, just and proper in the present facts and circumstances of the case."

2. Learned counsel for the applicants states that the applicants have preferred a representation dated 10.05.2018 and reminder dated 17.05.2018 in this regard and states that they will be happy and satisfied if a direction is given to the respondents to decide the said representation of the applicants in a time bound manner.

3. Taking into consideration the submission made by the counsel for the applicant at the Bar, we feel it unnecessary to keep the OA pending before this Tribunal and we direct the respondents to decide the aforesaid representation and reminder of the applicants by passing a reasoned and speaking order within three months from today. The OA is disposed of. It is made clear that nothing has been commented on merits of the case.

MA No.2485/2018 and MA No.2486/2018 are also disposed of.
