**ORDER(ORAL)****Hon'ble Mrs. Jasmine Ahmed, Member (J)**

This OA has been filed by the applicants seeking the following reliefs:-

- “(i). Declare the action of respondents in not giving promotions to the Electric Beldars/Beldars to next post of Electric motor driver or any other Post applicable, as illegal and unjustified.
- (ii) Further Direct the respondents to promote the Electric Beldars/Beldars to next post of Electric motor driver or any other Post applicable as given to those similarly situated persons as the applicants.
- (iii) Direct the respondents to consider the applicants for promotion in the respective cadre as per existing hierarchy from due date and with all consequential benefits including arrears of pay.
- (iv) to direct the respondents to hold cadre review and ensure atleast three promotions to the applicants in their respective cadre as available in the engg & Ministerial Cadre.  
OR Alternatively
- (v) Direct the Respondents to make avenues of promotion available for the cadre of Electric Beldars/Beldars to the post of Electric Motor Driver and in case the RR's are not available for holding the promotions, either make the RR's or implement the RR's of the similarly placed persons to the

applicant also to ensure that the Applicants are not left out without promotion in the lifetime of their services.

- (vi) To consider the claim of the applicants for promotion from the date of completion of required service prescribed for promotion in the RRs.
- (vii) to allow the OA with exemplary costs.
- (viii) to pass any such other order as this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the case."

2. Learned counsel for the applicants states that the applicants have preferred a representation dated 27.03.2018 (Annexure A-5), in this regard and states that they will be happy and satisfied if a direction is given to the respondents to decide the said representation of the applicants in a time bound manner.

3. Taking into consideration the submission made by the counsel for the applicants at the Bar, we feel it unnecessary to keep the OA pending before this Tribunal and we direct the respondents to decide the aforesaid representation dated 27.03.2018 (Annexure A-5) of the applicants by passing a reasoned and speaking order within three months from today. The OA is disposed of. It is made clear that nothing has been commented on merits of the case.

MA No.2461/2018 is also disposed of.
