**ORDER** (Oral)

Heard the learned counsel for the applicants for some time.

2. At the outset, Shri Susheel Sharma, learned counsel for the applicants states that he will be satisfied if representations of the applicants seeking relaxation in Rule 10 of CCS (Revised Pay) Rules, 2008 for release of one increment on 1<sup>st</sup> July 2009, are decided by the respondents by way of appropriate orders, in a time bound manner. Referring to one such application at Annexure A/7, he submitted that this representation alongwith others of similarly aggrieved applicants, is representative of the grievance of the applicants in OA.

3. In view of the limited prayer made by the learned counsel for the applicants, the respondents are directed to pass a reasoned and speaking order on the representations of the applicants within three months from the date of receipt of a certified copy of this order. The OA is, accordingly, disposed of, at the admission stage itself.

MA No.3827/2018 stands disposed, in view of the aforementioned directions.
