ORDER (ORAL)

When this matter is taken up for hearing, it is brought to our notice that the Hon'ble Apex Court in Civil Appeal No.1350/2018 in **Union of India and Others vs. K.V. Rama Raju and Others** and

batch, decided the same issue vide its judgment dated 31.01.2018, a copy of which is also placed before us by way of MA No. 2907/2018 filed in the O.A.

2. It is also not disputed that the subject matter of this O.A. is squarely covered by the said decision of the Hon'ble Apex Court, however, the learned counsel for the applicants submits that a Review has been filed against the said order and the same is pending as on today.

3. In the circumstances and in view of the decision of the Hon'ble Apex Court on the identical subject matter, we dispose of the O.A. in terms of the judgment of the Hon'ble Apex Court in Civil Appeal No.1350/2018 in **Union of India and Others** vs. **K.V. Rama Raju and Others** and batch, dated 31.01.2018. However, it is needless to mention that the same is again subject to the result of the Review pending before the Hon'ble Apex Court in the said order.
