ORDER (ORAL)

DR. K.B. SURESH, MEMBER (J):

1. Both counsel agree that in a connected matter the Tribunal had held in favour of the applicant and the Hon'ble High Court also had upheld that order. Again the respondents have gone to the Hon'ble Apex Court and the Apex Court having admitted the SLP, the matter is still now within the jurisdiction of the Hon'ble Apex Court. Both counsel submit that a conditional order can be issued to the effect that based on the Hon'ble Apex Court order appropriate benefits can be granted or not granted to the applicant, as the case may be. OA is, therefore, disposed of. No order as to costs.
