O R D E R (ORAL)HON'BLE DR K.B. SURESH, MEMBER(J)

Heard the matter in detail. We examined Annexure R-8 and find that the applicant herself had given her date of birth as 10.3.1952. It was given on 01.04.1981. Therefore, the case put up by the applicant is factually wrong. If the applicant's case is to be taken up, it would show that the applicant had not passed SSLC at that point of time as she was just 14 years at that point of time.

2. We examined other connected records and found that the applicant's date of birth has been given as 1952 in all the documents. We find that a frivolous and vexatious case has been taken up by the applicant and therefore has obtained interim order and continued in service for 5 more months.

3. Therefore, the OA is dismissed. No order as to costs.
