Apparently the applicant and the party respondent got 48 marks each in the Limited Departmental Competitive Examination. The respondents held the party respondent to be senior on the basis of his date of entry into service but it transpires that the party respondent is a Mail Deliverer and the applicant is a BPM therefore BPM will be more senior as he is superior to Mail Deliverer. Therefore the selection of 5th respondent is not correct. But at this stage we are reluctant to quash his appointment as he has already been appointed therefore we will direct the respondents to appoint the applicant now in a supernumerary post to be accommodated and adjusted later on as the distinction between the applicant and the 5th respondent is very narrow but in the seniority the applicant will, of course, be senior to the party respondent.

2. The OA is allowed as above. No order as to costs.
