O R D E R (ORAL)

HON'BLE DR. K.B. SURESH, MEMBER(J)

1. Heard. The matter relates to regularization of contract Announcers with All India Radio. The Ernakulam Bench of the Tribunal had directed the respondents to frame a scheme for their regularization. Following which a Committee was appointed and after having gone into the merit of the matter and in view of the fractured working hours, during which time the applicant needs to be available at the working place. For instance Shri Vishnu Bhat states that they have worked for a maximum of 6 days in a month that is less than 72 days in a year and therefore, it is difficult for them to regularize. However, after the Hon'ble High Court had passed an order, the matter reached the Hon'ble Apex Court now in SLP.No.13876 – 13877/2016. Therefore, we order that in terms of the order which may be passed by the Hon'ble Apex Court, the case of

the applicants may also be considered. As both counsel agree that they are also in parimateria situation with the original applicants in the other case. Therefore, the same benefits or otherwise will be extended to the applicants herein also.

2. OA is disposed off as above. No order as to costs.
