O R D E R (ORAL)

HON'BLE DR. K.B. SURESH, MEMBER(J)

1. Heard. Applicant was appointed Librarian on 18.3.1974. Thereafter, she was promoted as Senior Librarian on 27.5.1985. Thereafter, she was again promoted as Transmission Executive on 28.10.1987. Thereafter there was a merger of pay scale and an upgradation. But, then this upgradation or merger has no relevance to the issue at all as the Hon'ble Apex Court has maintained that this is non stagnation procedure and nothing more. Thereafter, it seems that the applicant had been again promoted as Programme Executive on 8.1.1999. Thereby completing the entire process as dictated by the Hon'ble Apex Court in terms of ACP orders as well as MACP orders. There is no merit in the OA.

2. OA is dismissed. No order as to costs.
