We heard the matter for some time. Apparently the relief sought for in the earlier OA could not be granted as the entity to which the applicant could have gone is not squarely within the ambit of the Railways now, even though by changing the nomenclature jurisdiction once again cannot be taken away, but be that as it may we feel that since the claim of the applicant is only to apply for a transfer somewhere near to his hometown, he may file an application for this and we will now permit him to file a fresh cause if his demand is not met. With this direction, we hold there is nothing in the OA to be agitated as of now.

2. The OA is dismissed. No order as to costs.
