1. Heard. The matter is in a very short compass. In accordance with Annexure A-1, Draft Recruitment Rules for the post of Administrative Officer, under clause 10, it is clearly answered that it is a promotional post failing which direct recruitment or transfer on deputation or short term contract appointment. Apparently, the applicant is eligible for promotion and therefore, he could not have been overlooked and a notification for direct recruitment issued. Therefore, Annexure A-2 notification is hereby quashed. A mandate is issued to the respondents to consider the applicant for the post of Administrative Officer within 2 months next.
