Heard. The matter relates to appointment of GDS BPM. Apparently, for a vacant post, a selection was conducted on merits and the 4th respondent was appointed. The applicant challenges his appointment on the ground that some service weightage ought to have been given for the applicant's appointment. But then, since he has not completed 3 years insitu, he cannot be put in weightage list to be considered at a later stage. Therefore, only merit is the criteria to be adopted in this. Since, admittedly the applicant lacks merit and the other person was selected and therefore there cannot be any genuine merit granted to the applicant.

2. OA lacks merit. Dismissed. No order as to costs.
