Heard. On 20.12.2017 we had passed an interim order to keep one post

vacant. The respondents admit that the applicant is a physically disabled person having 40% disability. Under Section 47 of the Disabilities Act such persons have got a privilege of being appointed to a post reserved for them. Apparently there is one such vacancy. The respondents say that it will be now considered under the new set of vacancies. That will not be required as we have already directed that one post be kept vacant. If he is otherwise eligible then the applicant will be appointed to the post. There will be a mandate to that effect.

2. The OA is allowed. No order as to costs.
