O R D E R (ORAL)

HON'BLE DR K.B. SURESH, MEMBER(J)

1. When the matter was taken up today for hearing Shri S.Prakash Shetty, learned counsel for the respondents invites our attention to paragraph 8 which is quoted below:-

“8.It is submitted that the proposal regarding placement of all Draughtsmen of DQA(N) cadre in the revised pay scales as per MoF OM dated 13.3.1984 without requirement of length of service was examined by MoD/Fin in consultation with MoF/DoE which agreed vide MoF UO.No.10(7)/E-IIIB/2014 dated 26.12.2014 (Annexure-R4) for revision of pay scales of Tracer on par with the Draftsmen of CPWD provided their recruitment qualification is exactly similar to D' Man of CPWD. The matter has been under consideration of MoD for a decision on the acceptance of entry level qualification of Tracers as being exactly similar to the D' Man of CPWD. As is apparent from the recruitment qualification stated in para 2 above, RRs of D'Man of CPWD stipulate practical training of 6 months whereas RRs of Tracers of DQAN contain no such condition in Essential Qualifications prescribed for the post. Respondent No.2 has submitted all relevant documents to MoD/D(QA) which is duly considering the matter.”

2. Therefore, in view of this fact, we do not think, we have to keep the matter pending. We, therefore, direct M/o Defence to complete the process within next 3 months time and for the concerned Ministry to grant appropriate benefits to the applicants under law within a further period of one month.

3. OA is disposed of. No order as to costs.
