**SANJEEV KAUSHIK, MEMBER (J):-**

1. M.A. No.60/1632/2018 and M.A. No.60/1633/2018 have been filed in both the OAs under Rule 4(5)(a) of the C.A.T. (Procedure) Rules, 1987, seeking permission to allow the applicants to file joint petition. For the reasons stated therein, the same are allowed.
2. This order shall dispose of the above captioned two O.As. as they involve identical facts, questions of law and relief claimed therein and likewise is also requested by learned counsel for the parties. For convenience, facts are taken from the case of Raj Mohan Singh & Ors. vs. UOI & Ors.
3. By means of present O.A., the applicants are seeking following relief(s):-
 

"8. For directing the respondents to recalculate the salary of all the applicants w.e.f. date of their initial appointment/joining keeping in view the Basic Pay alongwith DA (Dearness Allowance) as revised from time at par with their regular counterparts in terms of the judgment dated 8.12.2003 (Annexure A-3) passed by this Court in OA No.810/CH/2003 (Jaspal Kaur etc. vs. UOI) and as upheld by the Hon'ble Punjab & Haryana High Court vide its judgment dated 23.03.2005 (Annexure A-4) and further by the Hon'ble Supreme Court of India vide its judgment dated 4.3.2013 (Annexure A-6) and further in view of the ratio/spirit of the judgment dated 12.03.2001 passed by the Hon'ble Punjab and Haryana High Court in CWP No.15116 of 1998 (Anmol Rattan and others vs. State of Punjab and others) and as upheld by the Hon'ble Supreme Court of India on 15.04.2002 vide judgment dated 15.04.2002 (Annexure A-8) and further in view of the interim order dated 6.10.2016 (Annexure A-11) as passed by the Hon'ble Punjab and Hayana High Court in CM No.12642 of 2016 in CWP No.19280 of 2011 recently followed while allowing similar relief while disposing of OA No.833 of 2017 (suman Sharma and others vs. UOI and others) on 16.07.2018 (Annexure A-10) and disburse the arrears as consequences of such recalculation of salary w.e.f. the date of their initial appointment(s) along with interest @18% p.a."

4. Sh. Ranjivan Singh, learned counsel for the applicants submitted that similar issue has already been decided by this Court in O.A. No.60/833/2017 titled **Suman Sharma and others vs. UOI & Ors.** on 16.07.2018 where the applicants therein working as contractual employee were not granted benefit of basic pay plus dearness allowance based upon the case of **Vandana Jain & Others vs. UOI & others** (O.A. No.60/33/2010 decided on 31.03.2011). Learned counsel for the applicant submitted that orders of this Court is pending for judicial review in CWP No.19280 of 2011 wherein in CM No.12642 of 2016 Hon'ble High Court has ordered to release benefit subject to furnishing affidavits to the effect that the amount released would be subject to adjustment in the event of the decision of the writ proceedings against them. Learned counsel for the applicants submitted that since applicants are similarly placed and are ready to give the aforementioned undertaking, similar order be passed in these cases also.
5. Issue notice to the respondents.
6. At this stage, Sh. Arvind Moudgil appears and accepts notice on behalf of the respondents. He is not in position to make any other submission, as already made in the case of Suman Sharma (supra), which has been relied upon by the applicants.
7. Considering above and for parity of reasons given in the indicated judgment we dispose of this O.A. in the same terms as in the case of Suman Sharma (supra), relevant para of which reads as under:-

"5. We have given our thoughtful consideration to the matter and are of the view that when the Hon'ble High Court is seized of the matter, no fruitful purpose would be served by keeping it pending here. The O.A. is disposed of in terms of order dated 31.03.2011 in the case of Vandana Jain (supra), subject to the outcome of the Writ Proceedings in that case,

which is pending before the Hon'ble High Court. Accordingly, the impugned order (Annexure A-21) is hereby quashed. We may clarify here that the applicants are bound to furnish an affidavit, in terms of order dated 06.10.2016 (supra) of the Hon'ble High Court that the amount would be subject to the adjustment in the event of the decision of the Writ Petition aforementioned goes against the respondents therein."
