**SANJEEV KAUSHIK, MEMBER (J):-**

1. M.A. No.60/1914/2017 has been filed under Rule 4(5)(a) of the C.A.T. (Procedure), Rules, 1987, seeking permission to allow the applicants to file joint petition. For the reasons stated therein, the same is allowed.
2. Learned counsel for the applicants submitted that this O.A. can be disposed of in terms of order dated 24.11.2017 passed by this Court in O.A. No.60/181/2017, which was based upon order dated 27.04.2016 of the jurisdictional High Court in the case of **Kala Singh & Ors. vs. UOI & Ors.** (CWP No.7714/2016), which has also been affirmed upto the Hon'ble Supreme Court by disposing of SLP at the hands of the respondents to await deliberation to be given by the Railway Board. He further submitted that the applicants be given liberty to approach this Court after deliberation given by the Railways, if still applicants are dissatisfied.
3. Ordered accordingly.
