Taking into consideration, the common cause of action, similar nature of relief claimed, common interest in the matter, and for the reasons mentioned therein, the Miscellaneous Application (MA) is allowed. The applicants are permitted to join together to file the instant single application, as prayed for.

OA No.060/00131/2018

The main contention of learned counsel, at this stage, is that, although the applicants have moved representation dated 28.07.2017 (Annexure A-8), for redressal of their grievances, but no decision has yet been taken by the Competent Authority.

Having heard the learned counsel for the applicants, having gone through the record with their valuable assistance, after considering the entire matter and without expressing any opinion on merits, lest it may prejudice the case of either side, the instant main Original Application is disposed of with the direction to The Divisional Railway Manager, North Western Railway, (respondent no.2) to sympathetically consider and decide the indicated representation, by passing a speaking / reasoned order and in accordance with law, within a period of two months from the date of receipt of a certified copy of this order.
