**ORDER (Oral)**  
**SANJEEV KAUSHIK, MEMBER (J)**

1. By way of the present O.A., the applicants have sought quashing of order dated 10.02.2016 (Annexure A-21) issued by Respondent No. 3, whereby their claim for grant of basic pay along with the D.A., as revised from time to time, at par with their regular counterparts, has been rejected. They have also sought issuance of a direction to the respondents to grant them the benefit of basic pay +D.A., as is given to their regular counterparts.
2. After exchange of pleadings, the matter came up for final hearing.
3. Mr. Ranjivan Singh, learned counsel for the applicants submitted that he has placed various judgments on record, whereby this issue has already been settled by holding that the contractual employees are entitled to the grant of basic pay + DA, as is admissible to the regular employees. Learned counsel submitted that the same issue has also been put to rest by this Court in the case of **Vandana Jain & Others Vs. Union of India & Others** (O.A. No. 33/2010 decided on 31.03.2011). Therefore, learned counsel contends that once the issue has already been settled by the Court of law in favour of the applicants, then the

respondents cannot deny the benefit to the similarly situated employees. Learned counsel submitted that though a Writ Petition, on this issue, is pending adjudication before the Hon'ble High Court, but there is no stay order. On these grounds, learned counsel has prayed for quashing of the impugned order dated 10.02.2016 (Annexure A-21) and sought issuance of a direction to the respondents to grant the relevant benefits to the applicants, in terms of case of Vandana Jain (supra).

4. Mr. Vinay Gupta, learned counsel for the respondents, did not dispute the factual accuracy of the averments, noticed herein above. He added that Hon'ble High Court, in its order dated 06.10.2016 in C.M. No. 12642/2016, filed in the case of Vandana Jain (supra), has ordered to release the benefit, subject to furnishing of affidavit by the beneficiaries to the effect that this amount would be subject to the adjustment in the event of the decision of the writ proceedings against them. Therefore, he submitted that similar order on the above lines may be passed in this case also.

5. We have given our thoughtful consideration to the matter and are of the view that when the Hon'ble High Court is seized of the matter, no fruitful purpose would be served by keeping it pending here. The O.A. is disposed of in terms of order dated 31.03.2011 in the case of Vandana Jain (supra), subject to the outcome of the Writ Proceedings in that case, which is pending before the Hon'ble High Court. Accordingly, the impugned order (Annexure A-21) is hereby quashed. We may clarify here that the applicants are bound to furnish an affidavit, in terms of order dated 06.10.2016 (supra) of the Hon'ble High Court that the amount would be subject to the

adjustment in the event of the decision of the Writ Petition  
aforementioned goes against the respondents therein.

The O.A. stands disposed of with the above directions.
