O R D E R (O R A L)

MR. S.N. TERDAL, MEMBER (J):

This O.A. is filed by the Applicants seeking a direction to the Respondents to set aside and quash the Recovery Order of Special Duty Allowance No. Dib. 7(5)/2016-17/AC/172 dated 23.11.2016 and order No. DIB-14(1)/2016-2017/S/CAT/263-265 dated 30.05.2017.

2. Heard Mr. Adil Ahmd, learned counsel for the Applicants and Ms. G. Sutradhar, learned Addl. CGSC for the Respondents. Perused the O.A. and all the documents produced by both the parties.

3. A short question that arises in this case is as to whether the Special Duty Allowance paid w.e.f. 01.10.1998 to 31.08.2008 to the Applicants can be withdrawn by the Respondents. Admittedly, except Applicants at Sl. No. 4, 8, 9,

12, 15, 16, 18 and 40 who are Group 'B' employees, the others are Group 'C' and 'D' employees.

4. In so far as the said Group 'C' and 'D' employees are concerned, the recovery cannot be affected in view of para 4 (i) of O.M. No. 18/03/2015-Estt. (pay-1) dated 02.03.2016. In so far as Group 'B' employees are concerned, whether recovery could be made or not, is to be examined by the Respondents in the light of para 4(ii) & (iii) of the above OM.

5. In the circumstances, the Respondents are directed to examine the case of the above stated Applicants who are Group 'B' employees and pass a speaking order within a period of three months from the date of receipt copy of this order. Copy of the speaking order be furnished to the above stated Group 'B' employees.

6. O.A. stands disposed of accordingly. No order as to costs.
