Learned counsel for the applicants submits that all the 27 applicants have subsequently been promoted to the post of Loco Pilot (Goods), and therefore, this O.A has rendered infructuous.

2. Learned counsel for the applicants submits that though the O.A has rendered infructuous, however, the applicants have not been assigned proper seniority and pay and allowances at par with their juniors. Therefore, he seeks liberty to challenge these issues by filing a fresh Original Application.

3. Considering the above, this O.A is disposed of as having become infructuous. However, the applicants shall be at liberty to file a fresh Original Application, if their grievance still persists.
