The applicants are working as Junior Works Manager with
the respondent-department.

2. The applicants have submitted that the respondents have
issued notification dated 08.09.2017 (Annexure A-5) followed by
with another notification dated 20.03.2018 (Annexure A-6)
wherein the data required for holding DPC for promotion to the
Junior Works Manager (Selection grade) from Junior Works
Manager have been asked from various field units.

3. It is the case of the applicant that there is no Service
Recruitments Order (for short ‘SRO’) for the post of Junior Works
Manager (Selection Grade). Also no seniority list has been
published after 01.01.2014.

4. Accordingly, the applicants submit that in the absence of the
published seniority list and SRO, holding a DPC for Junior Works
Manager (Selection Grade) would be unjust.

5. The applicants have submitted that they have preferred representation raising their grievances. However, the same is kept undecided.

6. Learned counsel for the applicants submits that the applicants would be satisfied if their representation on the subject is decided with a reasoned and speaking order before proceeding ahead with the selection process.

7. Shri S.P. Singh, learned counsel appears on behalf of the respondents on receipt of advance copy of O.A. and submits that he has no objection if this Original Application is decided in above terms.

8. Accordingly, at admission stage itself, without going into the merits of the case, this Original Application is disposed off by directing the competent authority of the respondent-department to decide representations preferred by the applicants on 10.07.2018. Till such time representation is decided, the respondents are directed to not to proceed with the selection process.
