**ORDER (oral)**

**Per: Suresh Kumar Monga, Judicial Member**

With the consent of learned counsels for the parties, O.A. No. 291/43/2017, O.A. No. 291/44/2017, O.A. No. 291/45/2017, O.A. No. 291/49/2017, O.A. No. 291/50/2017 & O.A. No. 291/51/2017 are being disposed of together as a common question of law and facts is involved in all these cases.

2. In all these six cases, almost a similar prayer has been made. The applicants have prayed for issuance of a direction to the respondents to grant them the benefit of 1<sup>st</sup> ACP in PB-2 with Grade Pay of Rs. 4600 w.e.f. 01.01.2006 and 2<sup>nd</sup> ACP in PB-3 Rs. 15600-39100 with Grade Pay of Rs. 6600 w.e.f. 20.07.2007 and further 3<sup>rd</sup> MACP with Grade Pay of Rs. 7600 in the immediate next higher grade pay w.e.f. 20.07.2013.

3. During pendency of all these cases, the respondent no. 2. vide letter dated 21.04.2017 (Annexure A/13) decided that those Draughtsman / Technical Officers of Military Engineering Services, who have completed 24 years of regular service during intervening period of 01 January 2006 to 31 August 2008 shall be granted 2<sup>nd</sup> financial upgradation in the pre-revised scale of Rs. 10,000-325-15200 (Revised pay scale of PB-3 Rs. 15600-39100 with Grade Pay of Rs. 6600/-) and further 3<sup>rd</sup> MACP PB-3

with Grade Pay of Rs. 7600/- after completion of 30 years of regular service.

4. Pursuant to aforesaid letter, one more letter was issued by respondent no. 2 on 21.04.2017 (Annexure A/14) itself wherein all the concerned authorities were directed to forward ACP Proforma alongwith Integrity, Vigilance Clearance Certificate and ACRs for reckoning the period in respect of Draughtsman / Technical Officers, who have completed 24 years of regular service during intervening period between 01 January 2006 to 31 August 2008 for grant of 2<sup>nd</sup> financial upgradation under ACP Scheme. A copy of the said letter was also forwarded to Legal (O) for information with respect to the instant six cases pending before this Tribunal.

5. At the very outset, learned counsel for the applicants argued that while relying upon the letters dated 21.04.2017 (Annexures A/13 and A/14), the Ernakulam Bench of this Tribunal vide order dated 29<sup>th</sup> May, 2017 has already disposed of O.A. No. 180/00644/2014 (**Ushasree G. & Ors. vs. Union of India & Ors.**) with a direction to respondents to disburse the benefits arising out of the said letters dated 21.04.2017.

6. The above position has not been disputed by learned counsel for the respondents.

7. Accordingly, all these six Original Applications are allowed in the same terms of the order dated 29<sup>th</sup> May, 2017 passed by Ernakulam Bench of this Tribunal in O.A. No.

180/644/2014 - **Ushasree G. & Ors. vs. Union of India & Ors.** (supra). The respondents are directed to implement the directions contained in the letter dated 21.04.2017 (Annexure A/13) and disburse the benefits arising therefrom to the applicants, if they are otherwise found eligible as per the terms of ACP Scheme, within a period of three months from the date of receipt of a copy of this order.

8. Ordered accordingly. No order as to costs.
