THE INSTANT ORIGINAL APPLICATION HAS BEEN FILED BY THE APPLICANTS IN ORDER TO SEEK QUASHING OF THE PANEL LIST DATED 18.12.2014 WITH A FURTHER PRAYER TO RESTRAIN THE RESPONDENTS FROM MAKING PROMOTIONS ON THE POST OF PASSENGER GUARD ON THE BASIS OF SAID PANEL LIST.

2. THE APPLICANTS BEING GENERAL CATEGORY CANDIDATES ARE AGGRIEVED AGAINST EXECUTION OF POLICY CIRCULATED BY THE RAILWAY BOARD VIDE RBE NO. 126/2010 DATED 01.09.2010.

3. AT THE VERY OUTSET, SHRI KAMAL DAVE, LEARNED COUNSEL FOR RESPONDENT NOS. 1 TO 4 PRODUCED A CIRCULAR DATED 30.09.2016 ISSUED BY THE RAILWAY BOARD VIDE WHICH THE RBE NO.126/2010 DATED 01.09.2010 HAS BEEN KEPT IN ABEYANCE. IT HAS FURTHER BEEN LAID DOWN IN THE SAID CIRCULAR THAT ALL FURTHER PROMOTIONS OF RESERVED CATEGORY PERSONS TO UN-RESERVED POSTS WILL NOW BE MADE BY IGNORING THE RAILWAY BOARD RBE NO.126/2010 DATED 01.09.2010. IN VIEW OF THIS, THE LEARNED COUNSELS FOR THE PARTIES AGREED THAT THE INSTANT OA CAN BE DISPOSED OF IN THE LIGHT OF CIRCULAR DATED 30.09.2016.
