ORDER (Oral)

Per Ms. Bidisha Banerjee, Judicial Member:

Heard both.

2. MA. 350/659/2018 filed by the applicants (20 in numbers) for joint prosecution is allowed and the applicants are allowed to prosecute the remedy jointly.

3. We noticed that a representation dated 31.07.2018 preferred by the applicants to the Senior Superintendent of Post Offices seeking benefits of appropriate remuneration in accordance with the circular dated 22.01.2015 issued by the DOPT is pending before the said authority. Therefore, instead of calling for reply in the matter, as it would be futile exercise unless the decision is taken by the respondents on the pending representation, we dispose of the OA with a direction upon the Sr. Superintendent of Post Offices being the Respondent No. 3 in the present OA to consider the representation in the light of the circular operating in the field as well as the circular dated 22.01.2015 and dispose it of within a period of 8 weeks from the date of receipt of a copy of this order.

4. It is made clear that we have not gone into the merits of this case and all points are kept open for consideration by the respondent authorities.

5. In the event, the applicant is found entitled to the reliefs as prayed for, the concerned respondent authority shall extend such benefits within a period of 4 weeks thereafter.

6. Accordingly, OA would stand disposed of. No costs.
