ORDER (Oral)

Per Manjula Das, Judicial Member:

Heard Mr. A. Sengupta, Ld. Counsel for the applicants and Ms. M. Bhattacharyya, Ld. Counsel for the official respondents.

2. The applicant are the employees of Department of Posts and their grievance is that after introduction of Time Bound Promotion under BCR Scheme they are entitled to the promotional benefits. However, they were not granted the same.

3. Being aggrieved, they approached before this Tribunal seeking the relief as prayed for.

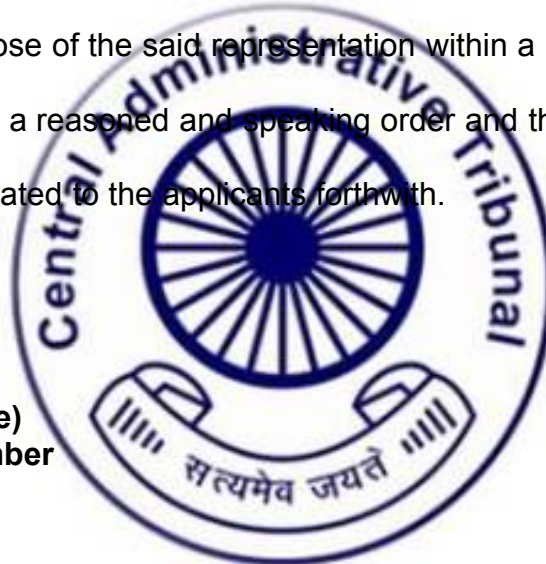
4. Ms. M. Bhattacharyya, Ld. Counsel appearing on behalf of the respondents, however, submitted that the applicants were awarded financial upgradation under TBOP Scheme w.e.f. 26.6.1993, 2.11.1993 as the case may be in accordance with the Ministry of Communication, Department of Posts, New Delhi order No. 22-5/95-PE-I dated 8.2.96. According to the Ld. Counsel the applicants are entitled to get the benefit after completion of 26 years of regular service, which has already been granted, as such, there is no scope to grant further relief.

5. Mr. A. Sengupta, Ld. Counsel for the applicant, however, submitted that

although the benefit was granted by the respondents but they did not get the benefits from the date when their juniors are granted the next higher scale of pay. Ld. Counsel further fairly prays before this Court that he would be satisfied if he is allowed to withdraw the Original Application by giving liberty to approach before the authorities by ventilating and narrating their grievances as per circular dated 8.5.2017. The Ld. Counsel for the respondents has no objection in this regard.

6. In view of the submissions made by Ld. Counsel, without entering into the merits of the case, we direct the applicants to make a comprehensive representation by ventilating their grievance as per circular dated 8.5.207 issued by the Ministry of Communication, Department of Post, within a period of one month from the date of receipt of a copy of this order. If so filed, the respondent authorities shall dispose of the said representation within a period of four months thereafter by passing a reasoned and speaking order and the decision so arrived at shall be communicated to the applicants forthwith.
