## O R D E R (ORAL)

Heard ld. Counsel for the applicant. None appeared for the respondents though service has been effected.

- It is the submission of the ld. Counsel for the applicant that the applicant was appointed in the South Eastern Railway on 1.8.1994 and while working as Head Cook in the East Coast Railway joined IRCTC on deputation and was absorbed in the IRCTC w.e.f. 1.1.2007. Since no pension and other retiral benefits have been paid to the applicant, he submitted a representation through proper channel which was duly forwarded to the competent authority But the settlement dues have not yet been released.
- It appears from the record that Annexure A/3 dated 8.10.2015 is a letter 3. written by Mr.C.R.Mishra, AFA(G) regarding forwarding of the representation made by the applicant, to CPO, East Coast Railway for payment of settlement dues to the Catering Staff of East Coast Railway presently working in IRCTC:

- 4. A representation has also been made on 2.6.2016 by the applicant to the Sr. Divisional personnel Officer, East Coast Railway, Khurdah Road with a copy to DRM, Khurda Road, E.Co.Rly. However, it has been alleged that till date no progress has been made for providing the settlement dues to the applicant.
- 5. Ld. Counsel for the applicant submits that he will be satisfied if the representations made by the applicant are considered by the respondent No.2 i.e. CPO, East Coast Railway.
- 5. Hence it is directed that the applicant shall place a copy of this order along with the OA to the respondent No.2 as expeditiously as possible. The respondent No.2 shall consider the representations of the applicant strictly as per rules within 2 months of getting a certified copy of this order and the



decision arrived at should be communicated to the applicant within 2 weeks thereafter.

- 6. It is made clear that I have not gone into the merits of the case and all the points are kept open for consideration by the respondents.
- 7. The OA is accordingly disposed of. No costs.
