ORDER (ORAL)



Heard ld. counsel for both sides.

2. Ld. counsel for the applicants submits that the instant application has been filed seeking the following relief:

- a) "An order granting leave to the applicants under Rule 4(5)(a) of the Central Administrative Tribunals (Procedure) Rules, 1987 to move this application jointly.
- b) An order directing the respondents to act and proceed in accordance with law and further directing them to grant the scale of pay Rs. 5000-8000/- to the applicants, making it at par with Goods Driver with all consequential benefits, retrospectively with effect from 1.1.1996 making it at par with Goods Driver following the order and judgment passed by the Hon'ble High Court at Calcutta in an identical matter being WPCT No. 208 of 2007 (being made Annexure A-1 to this Application) and was been granted to other similarly circumstanced Tower Wagon Drivers of Sealdah Division of the Eastern Railway.
- c) An order directing the respondents to produce the records relating to the matter before this Hon'ble Tribunal.
- d) And to pass such other further order or orders as this Hon'ble Tribunal may deem fit and proper.
- e) Costs and incidental thereto."

3. Ld. counsel for the applicants further states that the applicants had preferred a representation dated 15.02.2016, but the respondent authorities



are yet to respond. According to their Ld. counsel, the applicants will be satisfied if the respondent authorities are directed to dispose of the said representation in a time bound manner.

4. Accordingly, without entering into the merits of the case, we direct the competent respondent authorities to examine the contents of such representation, dated 15.02.2016 (Annexure A-4 to the O.A), and to pass a reasoned and speaking order in accordance with law within a period of 6 weeks from the date of receipt of this order.

5. With the above directions, the O.A is disposed of. No orders as on costs.
