Per Ms. Manjula Das, Judicial Member:

Ld. counsel Mr. A. Chakraborty appears for the applicants and Ld. counsel Mr.

B.P Manna appears for the respondents.

2. By way of this M.A No. 350/757/2017 the applicants prayed for permission to move the O.A no. 350/1235/2017 jointly as according to them their grievances are similar in nature and espousing common cause of action.

3. Having regard to the facts and circumstances of the case, the applicants are permitted to move the O.A jointly, under Rule 4(5) (a) of Central Administrative Tribunal (Procedure) Rules, 1987. Accordingly, the M.A 350/757/2017 stands disposed of.

4. Mr. A. Chakraborty Ld. counsel for the applicants submits, that the applicants will be satisfied, if permission is granted to them to file a comprehensive representation to the concerned respondent authority, highlighting their grievances, and the competent authority is directed to consider and dispose of the same within a time frame.

5. Ld. counsel for the respondents Mr. B.P Manna has no objection if such direction is given.



6. Accordingly, the applicants are permitted to file a comprehensive representation highlighting their grievances to the concerned respondent authorities within 15 days. The respondent authorities are directed to consider and decide the representations of the applicants within 2 months from the date of receipt of such representations, and pass a reasoned and speaking order as per Rules. The decision so arrived at shall be communicated to the applicants forthwith.

7. Accordingly, the both the O.A 350/1235/2017 and M.A 350/757/2017 stand disposed of.
